Dear Mr. Craver.

To put it more bluntly this place is no good, but unless your neighborhood speaks up it is doubtful whether Council will go to any length to find a more appropriate place for such activities.

Thanks for the kind words. It took quite a few years to get the 'norms' FIDE (Federation International des Echecs) required to get the title and I'm glad it's done. We're planning our flagship tournament the 2004 Paul Keres Memorial now for next May.

On the Upper Lynn issues I was pleased to see that the RCMP receptionist was incorrect - that the Bylaw officer WAS patrolling today though not Saturday or Sunday. This is a big concern for us in view of next Saturday's NSMBA 'Trail Day' in our area as the last one created bumper-to-bumper traffic in our area and in the park itself. (This was in July after the RPO designation but before it was being enforced.) It has come to my attention that despite the sign being ready, Susan Rogers refused permission to your sign man to post a "No Drop-Off" sign for our park entrance - due to an irate neighbor who has taken part in NONE of the Council meetings or public meetings on this issue.

The main issue in my books is that people like the bikers and this particular neighbor have flouted the established procedure for licencing, park dedication, signage and so forth and yet been rewarded for their intransigence by Council and Staff. Why does our civic government reward those who cheat and punish those of us who attempt to work within the system? It should in fact be the exact opposite.

My view is that park preservation issue is ONLY going to be resolved at the political level since I have no faith that the other side is seeking anything other than complete control of the park and that this means the total environmental devastation of the park. They don't appear to be interested in consensus except completely on their terms without any compromise at all. Please particularly note what I said in my last letter concerning illegal trail-building and illegal tree-cutting in the past four months inside the park.
