Councillor Crist:

The deadline for submitting reports is noon Monday, two weeks prior to the Council meeting. Your February 6 and February 9 reports were submitted after the deadline for the February 16 meeting.

Councillor Nixon's report was submitted in response to resolutions of Council dated September 15 & October 14, 2003. The September 15 resolution authorized the convening of a facilitated Lower Capilano Community Services Stakeholders' Forum. The October 14 resolution approved the Terms of Reference for the Forums, including the timeframe for presentation of the report (the end of January, 2004). At the same meeting, Councillor Nixon was appointed to represent Council on the Forum Steering Committee.

The facilitator's report is now completed and Councillor Nixon, as Council's representative on the Committee, has returned this issue to Council for further consideration. This is in accordance with the timeframe approved by Council on October 14, 2003.

It would seem to me that it would be reasonable to expect that, since this was a directive from Council, this issue would take precedence over new reports from Councillors. There is certainly no attempt to discriminate between Councillor's reports.
