Hi Agnes, West Vancouver was given verbal commitment of \$30,000 from the Celebrate Canada Day committee last year but when the fireworks were cancelled the money was not given to us for the fireworks and in the end we were given \$2,500 for our afternoon event which was spent for that purpose only. Therefore there is no unspent Federal money to be used towards fireworks this year and we are expecting to get word back about our 2005 application for funding early next week. We are not expecting the amount to surpass \$30,000 and if we are fortunate to receive the funding it is still not enough to cover the fireworks show and we would still be looking for funds from the District of North Vancouver. If we do not receive the Federal funding Councillor Clark has been working to secure corporate funding in lieu of this money but again we are still hoping to the District of North Vancouver will financially support this event. The City of North Vancouver has confirmed they will give \$5,000 for Canada Day fireworks. I hope that answers Councillor Cuthbert's question. Angela
