Hello Alasdair:

We are not talking about Mountain Biking ( stunt biking) in designated areas such as Whistler, or Cypress, GVRD, or Provincial Parks which is exactly what I have advocated after we have developed an Alpine Plan. The NSMBA is trying to avoid such a plan much as I am trying to avoid the plague. The NSMBA insists on stunt biking on the wet, forested, steep, and ecologically sensitive slopes of Mount Fromme which is adjacent to residential areas and, among other things, creates endless conflicts with residents. That is what we are talking about.

To suggest that I am against outdoor recreation is like suggesting that the Pope is anti Catholic. It is largely due to my efforts and that of another individual that the North Shore Mountains under the regional plan more than 30 years ago were set aside for regional recreation. Unlike the NSMBA and their vision poor political friends today, even then we were looking beyond the end of our noses.

I do not believe that you know what the situation is. As for Cam's contention that I should take a walk to see the trails for myself. That more than anything shows the absurdity of his argument. That is exactly what I am doing on an ongoing basis and he knows that but he continues to ignore it and spread his red herring propaganda to the contrary.

Not only am I an elected representative for the community in which Mount Fromme is located, I actually live close to Mount Fromme. Recently we even walked the trails with a CBC Television Crew. It has not been shown yet and the reason I believe is because it would confirm that Mountain biking, which is really stunt biking on Mount Fromme, is not a good idea.

So that you are clear about my position, I have and continue to advocate that we produce an Alpine Recreation Plan so we can deal with these issues on a magnitude commensurate with the potential of the whole North Shore rather than piecemeal and ad hoc as advocated by Cam and his misguided friends - unfortunately also with the assistance of run of the mill politicians, who also and nearly always, act first and think later, thus costing the taxpayers countless grief and money. As for my response to you, I am challenging the NSMBA to put his on their web. After all, I am putting everything they have to say on mine.
