It is my understanding that the DNV has made some kind of <u>"Trail Maintenance Service Agreement"</u> with the NSMBA! It is clear that the heavily flogged mountain bike trails, built by DNV and NSMBA, among many other questionable sponsors and funders, <u>are clearly beyond repair or maintenance</u>, as you can see by all the erosion photos from this pdf plan, alone, for an "<u>All Access" Trail for three and four wheeled mountain bikes</u>:

So, the NSMBA "<u>has to</u>" reroute, realign, bypass, etc. the trail, cutting and digging up more of our forest floor, wildlife habitat and trees for this very unnecessary project? This is as far from sustainable, nor anything remotely resembling "trail maintenance", as you can get. (I managed to acquire the 'secret' pdf plan off the NSMBA website. It was not published on the DNV.org site, sadly. The general public have no idea of this environmentally destructive "undertaking" that <u>has already begun</u> to degrade more of our forest floor, wildlife habitat, and trees.)

Keep in mind all the celebration over this trail, <u>opened a mere three years ago</u>, that was supposedly built by those who "graduated" from Capilano College with a "Mountain Bike Operations Certificate". The lack of public knowledge of this new <u>All Access road/trail (Bobsled, etc.)</u> being built to accommodate more destructive mountain biking, and maybe "invite" unwelcome motorized off road use (because of the new access trail) is shameful! <u>Will hikers be "forced" to share this trail with two, three and four wheeled vehicles barreling down it, also?</u> Are hikers even "welcome" on such a road/trail? **Is this really what Mayor and Council have approved of since 2008?** What a convoluted mess of "planning" for our Alpine...and the so-called Trail "Maintenance" agreement made with the NSMBA is going to become another very expensive boondoggle for DNV taxpayers. What more is there left to say?


