Thank you for forwarding the NSMBA the emails and concerns of Mrs. Monica Craver.

In reviewing the first email dated March 17, 2015 with the subject: "Who's minding the Fromme Forest?" I would like to state the following:

All work conducted by the NSMBA on DNV land is done in accordance and within the boundaries of the formal agreement between the DNV and the NSMBA. The NSMBA must present a work plan to the DNV for any and all trail maintenance done on Fromme. Work may only begin once the plan is approved.

The work the NSMBA undertakes is always conducted under the supervision of a master builder or Trail Adoption Plan (TAP) leader. The NSMBA has a program in place called the Builders Academy, the graduates of this course (now over 600) go on to become part of the NSMBA Shore Corps program which helps carry on the volunteer work.


