The issue here is the lens through which you're looking at this. You seem to be set on interpreting Pete's trail work as "damage" or "vandalism" to the rock in question. This is seriously flawed -- applying the same logic would mean that you should characterize any trail work done on the shore as "vandalism." Of course, this is ridiculous -- almost entering Monica-like territory.

It's too bad that a feature that you clearly valued has been altered. However, perhaps next time you

should be asking constructive questions and keeping an open mind as to why an experienced (and legendary) trail builder is changing a line rather than labelling it as vandalism.

Your answer will speak volumes about what District of North Vancouver values. It will help the public to better understand the ethics of our local government. It is only a fair and balanced question. What say you?
