I was mountain biking before most of the membership of the NSMBA could ride on two wheels.

I worked with land managers to allow mountain biking in the Don Valley in Toronto in the early 1990s. I even raced with a pro license for a bit, earning me a Mountain Bike World Cup point in Quebec City in 1997.

I can assure you that the actions of the NSMBA are neither condoned or endorsed by any reputable mountain bike or cyclist federation in the world. Their definition of trail building runs contrary to virtually every trail building best practice published and promoted by the International Mountain Biking Association (IMBA).

From a safety perspective, whitewater biking and riding on show covered surfaces is reckless. There is one exception re snow riding. I have ridden in snow. It is fun. But it <u>MUST</u> be in a closed environment on a course created for snow cycling, ideally a <u>commercial</u> trail which is monitored <u>every morning and constantly during the day in case of changing weather.</u>

Mountain biking on the North Shore is "sexy." It gets headlines and the photos/videos make excellent media content. I wish we had a commercial business here such as the one I frequented in Ontario, Hardwood Hills.

While the NSMBA has pushed out the envelope the environmental problems created by predatory trail building and irresponsible riding ultimately rest with the land manager, in this case the District of North Vancouver.

Yet it is not just the riding and trail building that concern me. Recently male members of the NSMBA secreted cameras on trails to video Lord knows who and what. Videoing and cameras absolutely have a place on trails for safety purposes and trail users must be advised they are on camera. But the members of the NSMBA who secretly videoed women on North Shore trails are nothing but common perverts and voyeurs and should have been criminally charged. Instead the RCMP showed the worst of judgement by lauding them for their boorish and adolescent behaviour. The members of the NSMBA acted like adolescent boys from the
